

# MIDWEST HORSEMANSHIP

Breeding Contract for METILION via FROZEN SEMEN

SEASON 2024

Owned by: Midwest Horsemanship - Daniel Schrock Green Forest, Arkansas (479) 979-4411.

## Terms and Conditions

I hereby confirm my reservation to the stallion, METILION for the 2024 breeding season. I understand and accept the following items:

1. It is the mare owner's responsibility to determine [by veterinary examination] that the mare is in sound breeding condition and free of infection.
2. The buyer of this semen understands, and agrees to have the mare inseminated by a veterinarian experienced in equine reproduction who has access to a veterinary ultrasound machine, will breed the mare within 6 hours of ovulation, and will strictly follow the frozen semen and insemination protocol with the semen. Frozen semen requires extreme care in handling and the buyer understands that attempts to use frozen semen outside the controlled situation of the equine reproduction center can greatly reduce or even prevent chances of conception. It is highly recommended that only mares that are reproductively normal be used for insemination with frozen semen.
3. The buyer agrees to pay a \$350 non-refundable deposit that is due with the return of this contract along with a **copy of the mare's registration papers**. The deposit is applicable to the total purchase price of this contract. Total contract price is \$1250 which includes the \$350 booking fee.
4. **Stud Fee:** All fees, charges and deposits, due to the stallion owner, must be paid before the delivery of semen. Remit payment of all fees, balances and deposits associated with the \$1250 stud fee to:

5. **Frozen Semen Ordering and Shipping Fee Payment:** Each purchase entitles mare owner to a single shipment of frozen semen. The frozen semen transportation {shipping} fee is +/- \$150 depending on destination location; all semen transportation costs are to be paid directly to the storage facility at the time of order. The information necessary to contact the storage facility will be provided by the stallion owner once the stud fee of \$1250 is paid in full. Contact the stallion owner, Daniel Schrock, via (479) 979-4411 or (479) 979-4398 to receive the information needed to order the frozen semen directly from the storage facility.
6. If contracted mare does not settle into pregnancy with first shipment, additional doses of frozen semen can be purchased for \$250 each plus transportation [shipping] fee.
7. The Buyer agrees to have the mare pregnancy checked by a licensed veterinarian within 14-55 days after the mare was last inseminated and the mare insemination form be filled out, signed and returned.
8. The mare owner understands and agrees to assume all responsibility for the condition of the mare and shall bear all risk of loss, damage or injury to the mare from any cause whatsoever, and therefore agrees to hold the Stallion Owner or any person employed by or associated with the Stallion Owner, harmless for any injury or illness to the mare associated in any way with breeding using frozen semen provided by the stallion owner.

9. The Buyer specifically understands that the stallion owner makes no warranties or guarantees, either expressed, implied or by any other means of interpretation in connection with this agreement. And further understands that the stallion owner shall be held harmless for any errors, failed inseminations, failure of the mare to conceive, failure of the mare to reach term, diseases or injuries to the mare, or any other mishaps attributable to frozen semen artificial insemination.
10. If the mare listed under this contract is unable to be bred, the mare owner, upon written request, can replace the mare only with prior written approval of the stallion owner, Daniel Schrock.
11. It is agreed that should the mare be sold or change ownership after being bred to the Stallion, re-breed privilege will no longer be valid.
12. This Contract contains a **Live Foal Guarantee**. A live foal is defined as a newborn foal which stands and nurses. If a foal is born dead, there are return privileges for the current season only if Daniel Schrock is notified within 10 days. If, after the mare is pronounced safely in foal, the mare should miscarry, abort, or prove barren, the mare owner has the privilege to return for breeding during the current breeding season or the following year, 2024.
13. A Breeder's Certificate will be issued for the foal when all fees have been paid in full and the Stallion owner is notified that a foal has been born. Contract is for one foal from contracted mare only.
14. In the event that it may become necessary for the Stallion Owner to employ an attorney to enforce the terms and conditions of this agreement, the Mare Owner agrees to pay all reasonable attorney fees, arbitration and/or court costs expended by the Stallion Owner through and including the execution of any judgment[s].
15. All PayPal **business** payments must be accompanied by a 3% processing fee. 3% of the total being paid, must be added to each PayPal business transaction sent to Midwest Horsemanship or there will be an outstanding balance that could cause delay or inability to order semen until all fees and dues are paid. Payments made through the PayPal Friends/Family option do not require the addition of a processing fee.
16. This Contract represents the entire agreement between the parties. No other agreements or promises, verbal or implied, are included unless specifically stated in this written contract.
